18 **TO ALL INTERESTED PARTIES:**

19 1. On or about March 29, 2012, the Bureau for Private Postsecondary Education  
20 (“Bureau”) received an Application for Renewal of Approval to Operate an Institution Non-  
21 Accredited (application number 24628) from the Institute of Buddhist Studies (“Respondent”).  
22 On or about August 8, 2016, via a Notice of Denial of Application for Renewal of Approval to  
23 Operate, the Bureau denied Respondent’s application.


24 2. On or about July 13, 2017, Joanne Wenzel, Chief of the Bureau for Private  
25 Postsecondary Education, filed Statement of Issues No. 1002147 solely in her official capacity.  
26 After the filing of that Statement of Issues, Respondent provided additional documents intended  
27 to resolve issues of non-compliance in Respondent’s application.

1           3.     The Bureau hereby withdraws Statement of Issues No. 1002147. The basis for the  
2 withdrawal of this pleading is that Respondent has now provided the documents and other  
3 information necessary for its renewal of licensure.

4           4.     WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.  
5 1002147 is hereby withdrawn without prejudice.
