**NOTICE OF WITHDRAWAL OF**  
**STATEMENT OF ISSUES**

19 **TO ALL INTERESTED PARTIES:**

20 1. On or about September 28, 2011, the Bureau for Private Postsecondary Education  
21 received an Application for Renewal of Approval to Operate an Institution Non-Accredited from  
22 Institute of Psycho-Structural Balancing, a corporation owned individually by Lisa Schwab  
23 (Respondent). On or about September 26, 2011, Lisa Schwab certified under penalty of perjury  
24 to the truthfulness of all statements, answers, and representations in the application. Multiple  
25 deficiency letters were sent to Respondent. The Bureau denied the application on June 26, 2015.  
26 Respondent requested an appeal of the denial.

27 2. On or about February 19, 2016, Joanne Wenzel, Chief of the Bureau for Private  
28 Postsecondary Education, solely in her official capacity, filed Statement of Issues No. 1000839.


1           3.     On or about March 3, 2016, Respondent requested an administrative hearing. Based  
2 on this request, a hearing was scheduled for December 6, 2016.

3           4.     The Bureau hereby withdraws Statement of Issues No. 1000839. The basis for this  
4 withdrawal is that on November 29, 2016, the Bureau's counsel received Respondent's Notice of  
5 Withdrawal of Request for Hearing.

6           4.     WHEREFORE, IN THE INTEREST OF JUSTICE, Statement of Issues No. 1000839  
7 is hereby withdrawn without prejudice.
