§71920 - Admissions Standards and Transferred Credits Policy	(a)(2) Each student admitted into a post-baccalaureate degree program shall possess a bachelor's degree or its equivalent. If a graduate program leads to a profession or an occupation requiring state licensure and the licensing agency does not require that a member of the profession or occupation possess a Bachelor's degree or its equivalent, this subdivision does not apply. Some student files failed to contain documentation of post-baccalaureate work.
