- 22 1. On or about December 15, 2017, Dr. Michael Marion, Jr., Chief of the Bureau for  
23 Private Postsecondary Education, Department of Consumer Affairs (hereinafter "Bureau"), filed  
24 Statement of Issues No. 1001710 solely in his official capacity.
- 25 2. On or about February 18, 2014, the Bureau for Private Postsecondary Education  
26 received an Application for Renewal of Approval to Operate and Offer Educational Programs for  
27 Non-Accredited Institutions ("application") from Training Institute for Addiction Counselors  
28 ("Respondent"). On or about February 13, 2014, Terri Melvin, Respondent's Chief Executive

1 Officer, certified under penalty of perjury to the truthfulness of all statements, answers, and  
2 representations in the application. The Bureau denied the application on or about March 2, 2016.

3 3. The Bureau hereby withdraws Statement of Issues No. 1001710. The basis for the  
4 withdrawal is that Respondent has satisfied the requirements for an Approval to Operate.

5 4. WHEREFORE, IN THE INTEREST OF JUSTICE, Statement of Issues No. 1001710  
6 is hereby withdrawn without prejudice.
