21 TO ALL INTERESTED PARTIES:

22 1. On December 8, 2020, Dr. Michael Marion, Jr, Chief of the Bureau for Private  
23 Postsecondary Education, Department of Consumer Affairs filed Statement of Issues No.  
24 1006286 solely in his official capacity.

25 2. On or about November 13, 2019, the Bureau for Private Postsecondary Education  
26 received an Application for Verification of Exempt Status (Application) from Psychoanalytic  
27 Center of California from owner Jennifer Langham, PhD. (Respondent). After notices of

1 deficiencies, on or about June 3, 2020, the Bureau denied the Application. Thereafter, the Bureau  
2 received a letter from Respondent requesting an administrative hearing.

3 3. Respondent has now provided the documents and other information necessary to cure  
4 all deficiencies in its Application for Verification of Exempt Status to receive a Verification of  
5 Exempt Status. Moreover, Respondent submitted a notice, dated January 12, 2021, withdrawing  
6 Respondent's letter requesting a hearing.

9 is hereby withdrawn without prejudice effective upon signature.
