20 1. On or about March 8, 2013, the Bureau for Private Postsecondary Education (Bureau)
21 received an application for a Renewal of Approval to Operate and Institution Non-Accredited
22 (Application Number 25913) from Dublin Beauty College (Respondent), which had been
23 operating as an approved school since on or about March 1, 1982, with School Code Number
24 0100371. On or about March 29, 2016, the Bureau denied the application. On or about May 10,
25 2016, Respondent requested an administrative hearing.


26 2. On or about December 7, 2016, Joanne Wenzel, solely in her official capacity as
27 Chief of the Bureau for Private Postsecondary Education, filed Statement of Issues No. 1001763
28 against Respondent.
