21 1. On or about August 29, 2017, Leeza Rifredi, Deputy Bureau Chief of the Bureau for  
22 Private Postsecondary Education, Department of Consumer Affairs (hereinafter "Bureau"), filed  
23 the First Amended Statement of Issues No. 1002383 solely in her official capacity.

24 2. On or about January 12, 2016, the Bureau received an application for a Renewal of  
25 Approval to Operate a Non-Accredited Institution (Application No. 28924) from School of  
26 Holistic Touch, Inc., Armando Reyna, owner, Institution Code Number 93794268  
27 ("Respondent"). On or about January 7, 2016, Armando Reyna certified under penalty of perjury

2 January 3, 2017, the Bureau denied Respondent's application.

3 3. The basis for withdrawing the pending Statement of Issues in Case No. 1002383 is

5 deficiencies and receive an Approval to Operate an Institution Non-Accredited.

6 4. WHEREFORE, IN THE INTEREST OF JUSTICE, Statement of Issues No. 1002383  
7 is hereby withdrawn without prejudice.
