- 21 1. On or about September 6, 2017, Dr. Michael Marion, Jr., Chief of the Bureau for
22 Private Postsecondary Education, Department of Consumer Affairs (hereinafter "Bureau"), filed
23 Statement of Issues on No. 1002210 solely in his official capacity.
- 24 2. On or about March 14, 2012, the Bureau for Private Postsecondary Education
25 ("Bureau") received an application (Application) for a Renewal of Approval to Operate an
26 Institution Non-Accredited from Trinity School of Nursing, Ma Antonietta BorrueI (BorrueI),
27 owner (Respondent). On or about February 29, 2012, BorrueI certified under penalty of perjury

1 to the truthfulness of all statements, answers, and representations in the application. The Bureau
2 denied the application on September 14, 2016.

3 3. The basis for withdrawing the pending Statement of Issues in Case No. 1002210 is
4 that Respondent has now provided the documents and other information necessary to cure all
5 deficiencies to receive Approval to operate as an Institution Non-Accredited.

6 4. WHEREFORE, IN THE INTEREST OF JUSTICE, Statement of Issues No. 1002210
7 is hereby withdrawn without prejudice.
