17 1. On or about June 22, 2011, the Bureau for Private Postsecondary Education,  
18 Department of Consumer Affairs (hereinafter "Bureau") received an Application for Approval to  
19 Operate for an Institution Non-Accredited, Application # 23672 from MTI College, predecessor  
20 to 3G University submitted by David Pinnell (hereinafter "Respondent"). On or about January  
21 13, 2017, the Bureau denied the application. On or about March 8, 2017, Respondent appealed  
22 the denial and requested an administrative hearing. Based on this request, a hearing was  
23 scheduled for July 30-31, 2018.

24 2. Dr. Michael Marion, Jr., Bureau Chief of the Bureau for Private Postsecondary
