LICENSING HISTORY

1. On or about August 27, 2015, the Bureau issued an Approval to Operate a Private Postsecondary Institution to Aero Tech Academy, Inc. (hereinafter referred to as the "Institution"). This Approval to Operate expired on or about August 26, 2020, and has not been renewed.

DISCIPLINE HISTORY

2. The Institution has the following discipline history:

CITATION JURISDICTION

3. This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

CAUSE FOR CITATION & ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR section 71930 (c)(3), (c)(4), (e) – Maintenance of Records

Cause for Citation: On or about July 20, 2022, the Bureau conducted an unannounced compliance inspection pursuant to CEC 94932.5(a). Bureau staff determined that the Institution did not have personnel present during normal business hours that could assist with the inspection. Additionally, Bureau staff made attempts to contact the Institution by phone to gain access to the Institution for the unannounced compliance inspection.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class A” violation. The Institution is issued a fine of \$5,000.00.

Order of Abatement: N/A

Violation #2:

5 CCR section 74110 – Annual Report in conjunction with CEC section 94934 – Annual Report

Cause for Citation: A review of the Bureau’s records confirm the Institution failed to submit all components of the 2021 Annual Report which was due to the Bureau by December 1, 2022. A reminder notice was sent to the Institution on or about the following dates: June 28, 2022, July 14, 2022 and July 26, 2022.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a “Class A” violation. The Institution is issued a fine of \$5000.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit the 2021 Annual Report pursuant to 5 CCR section 74110 and CEC section 94934.
