
24 1. On or about May 28, 2013, the Bureau for Private Postsecondary Education (Bureau)
25 received an application for an Application for Renewal of Approval to Operate a Non-Accredited
26 Institution from Edison Truck and Bus Driving School, Inc., Edison D. Freire, Tonnie P. Freire,
27 Mirella C. Freire (Respondent). The Bureau denied the application on February 7, 2017.
28 Respondent appealed the denial and submitted a request for administrative hearing.

1 2. On or about November 15, 2017, Dr. Michael Marion, Jr., Chief of the Bureau for
2 Private Postsecondary Education, Department of Consumer Affairs, filed Statement of Issues No.
3 1002479 solely in his official capacity. After initiating this action, Respondent provided
4 additional documents and information intended to resolve the issues of non-compliance in
5 Respondent's application.

6 3. The Bureau hereby withdraws Statement of Issues No. 1002479. The basis for the
7 withdrawal of this pleading is that Respondent has now provided the documents and other
8 information necessary for its application for licensure to be in compliance with the law.

9 4. WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.
10 1002479 is hereby withdrawn without prejudice.
