20 **TO ALL INTERESTED PARTIES:**

- 21 1. On or about August 18, 2017, Leeza Rifredi, Deputy Chief of the Bureau for Private
22 Postsecondary Education, Department of Consumer Affairs (Bureau), filed Statement of Issues
23 No. 1002256 solely in her official capacity.
- 24 2. On or about March 26, 2012, the Bureau for Private Postsecondary Education
25 (Bureau) received an Application for Renewal of Approval to Operate an Institution Non-
26 Accredited from Au Lac Institute (Respondent). On or about April 26, 2012, and August 12,
27 2015, the Bureau issued to Respondent letters explaining the deficiencies in its application. On or
28 about May 14, 2012, and June 20 and 27, 2016, respectively, the Bureau received a response from

1 Respondent. On or about September 20, 2016, the Bureau issued to Respondent a Notice of
2 Denial of Application for Renewal of Approval to Operate. On or about November 21, 2016, the
3 Bureau received a request for an administrative hearing from Respondent.

4 3. The basis for withdrawing the pending Statement of Issues No. 1002256 is that
5 Respondent has now provided the documents and other information necessary for its renewal of
6 approval to operate.

7 4. WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.
8 1002256 is hereby withdrawn without prejudice.
