22 1. On or about December 27, 2019, Dr. Michael Marion, Jr., Chief of the Bureau for
23 Private Postsecondary Education, Department of Consumer Affairs (hereinafter "Bureau"), filed
24 Statement of Issues No. 2020011119 solely in his official capacity.

25 2. On or about July 13, 2020, the Bureau, issued Verification of Exempt Status Number
26 31890 to Los Angeles Institute and Society for Psychoanalytic Studies; Lanning Melville
27 (hereinafter "Respondent").

1 3. The basis for withdrawing the pending Statement of Issues in Case No. 2020011119
2 is that Respondent has presented mitigating factors that allow for verification of Respondent’s
3 exempt status application including, but not limited to, a change in Respondent’s educational
4 program such that degrees are no longer offered, and non-professional/unlicensed individuals are
5 not permitted to take courses for credit.
