21 **TO ALL INTERESTED PARTIES:**

22 1. On or about September 8, 2016, Joanne Wenzel, Chief of the Bureau for Private  
23 Postsecondary Education, Department of Consumer Affairs (Bureau), solely in her official  
24 capacity, filed Statement of Issues number 1001522.

25 2. On or about January 4, 2013, the Bureau for Private Postsecondary Education  
26 received an Application for Approval to Operate for an Institution Non Accredited from The  
27 Broadcasters and Sportscasters Mentoring Group (Respondent). After several notices of

1 deficiencies and some further information from Respondent, on or about February 29, 2016, the  
2 Bureau denied the application. On or about March 11, 2016, the Bureau received a letter from  
3 Respondent requesting an administrative hearing.

4 3. The basis for withdrawing the pending Statement of Issues number 1001522 is that  
5 Respondent has now provided the documents and other information necessary to cure all  
6 deficiencies and receive Approval to Operate for an Institution Non Accredited.

7 WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues number 1001522  
8 is hereby withdrawn without prejudice effective upon signature.
