Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

CITATION

A Citation is hereby issued to Custom Training Solutions, CVSJ, Owner of P. Steve Ramirez Vocational Training Centers (Institution) located at 1800 W. Shaw, Suite 1A, Fresno, CA 93711, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

BACKGROUND

On April 3, 2019, Bureau staff conducted an unannounced Compliance inspection at the Institution. As a result of two minor violations that were unable to be cleared before the end of the inspection, the Institution was issued a Notice to Comply #CU 2701161 0419 (NTC). The Institution was given thirty days from the date of the inspection to either remedy all violations listed on the NTC or submit a written Notice of Disagreement. A Notice of Disagreement was not received. The Institution was able to clear one of the two violations from the NTC.

VIOLATION

#	Below you will find the California Education Code (CEC) and/or Title 5 of the California Code of Regulations (5, CCR code) section(s) of law you are charged with violating.
1.	<p>Violation:</p> <p>CEC Section 94935(b)(h) – Notice to Comply</p> <p><i>“(b) An institution that receives a notice to comply shall have no more than 30 days from the date of inspection to remedy the noncompliance.</i></p> <p><i>(h) If an institution fails to comply with a notice to comply within the prescribed time, the bureau shall</i></p>

take appropriate administrative enforcement action.”

The Institution failed to comply with the NTC within the prescribed time of 30 days. The Institution was unable to submit proof of compliance with the following laws and regulations:

5, CCR Section 71720(b)(2) – Faculty

“(b) Instructors in an Educational Program Not Leading to a Degree.

(2) Each instructor shall maintain their knowledge by completing continuing education courses in his or her subject area, classroom management or other courses related to teaching.”

Order of Abatement:

The Bureau orders the Institution to submit proof of compliance with the NTC violation listed above. (See attached NTC).

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the ‘Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing’ form (enclosed) within 30 days from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.*

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **April 5, 2020**, you will be deemed to have waived or forfeited your right to appeal this matter.
