- <sup>4</sup> “Graduates Employed in the Field” means graduates who report that they are gainfully employed within six months of graduation in a position for which the skills obtained through the education and training provided by the institution are required or provided a significant advantage to the graduate in obtaining the position.

## Salary and Wage Information (continued)

**Mean Wage** is the estimated total wages for an occupation divided by its weighted survey employment. The wage is provided for hourly and annual wage rates.

Most employees are paid at an hourly rate by their employers and may work less than or more than 40 hours per week. The **Mean Annual Wage** is calculated by multiplying the mean hourly wage by a "year-round, full-time" hours figure of 2,080 hours per year (52 weeks by 40 hours). Thus, the annual wage estimates may not represent the actual annual pay received by the employee.

\*\* Salary figures were taken from data collected and provided by the California Employment Development Department's (EDD) Occupational Employment Statistics (OES) 2011 survey. The wages have all been updated to the first quarter of 2012 by applying the US Department of Labor's Employment Cost Index to the 2011 wages. Occupations are classified using the Standard Occupational Classification (SOC) codes.
