## REPORTING OF GRADUATION RATE

The graduation rates reported in the School Performance Fact Sheet were developed by the U.S. Department of Education's National Center for Education Statistics, to be used for the Integrated Postsecondary Education Data System (IPEDS), Graduation Rate Survey. These national standardized rates were devised so that graduation rates could be compared across institutions.

The graduation rate tracks a cohort of students (defined as new-entering, full-time, first-time, degree-seeking) from their time of initial enrollment in an institution until they complete a bachelor's degree at the same institution.
