- 3-"Graduates" is the number of students who completed the program within 100% of the published program length.
- 4-"Completion Rate" is the number of Graduates divided by the Number of Students Available for Graduation.
- 5-"150% Graduates" is the number of students who completed the program within 101-150% of the published program length.
- 6-"150% Completion Rate" is the number of students who completed the program in the reported calendar year within 101-150% of the published program length divided by the Number of Students Available for Graduation in the published program length. Students that graduated after 150% of the published program length are not listed.

### **Method of Calculation**

Graduates unavailable for employment means graduates who, after graduation, die, become incarcerated, are called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.
- 2-"Graduates employed in the field" means graduates who have completed the program within 100% of the published program length who are gainfully employed in a single position for which the institution represents the program prepares its graduates within six months after a student completes the applicable educational program. For occupations for which the state requires passing an examination, the period of employment shall begin within six months of the announcement of the examination results for the first examination available after a student completes an applicable educational program.
- 3-Salary is as reported by the student. Not all graduates reported salary.
