LICENSING HISTORY

 On or about February 1, 2021, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to California College of Natural Medicine, Inc. (hereinafter referred to as the "Institution"). This Approval to Operate will expire on or about February 1, 2026, unless renewed.

DISCIPLINE HISTORY

2. The Institution has no prior discipline history.

CITATION JURISDICTION

3. This administrative citation is issued to the Institution pursuant to California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5 CCR) section 75020 et seq. for the violation(s) described below.

CAUSE FOR CITATION & ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR section 76130 – Collection and Submission of Assessments

Cause for Citation: The Institution failed to submit the Student Tuition Recovery Fund (STRF) Assessment Reporting form and the collection assessment fees as required for the 2nd, 3rd, and 4th quarter reporting periods of 2022.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$501.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit the Student Tuition Recovery Fund (STRF) Assessment Reporting form and the collection assessment fees as required for the 2^{nd} , 3^{rd} , and 4^{th} quarter reporting periods of 2022.

Violation #2:

5 CCR section 71930 (c)(3), (c)(4), (e) – Maintenance of Records

Cause for Citation: On or about September 14, 2022, the Bureau arrived at the Institution to conduct an announced compliance inspection pursuant to CEC 94932.5 (a). Bureau staff visited the Institution's physical address at 143 Figueroa Street, Suite 17, Ventura CA, 93002 as well as Institution's mailing address at 1237 South Victoria Avenue, Suite 169, Oxnard, CA 93035, which are the addresses on file with the Bureau. Bureau staff determined that the Institution did not have personnel present during normal business hours that could assist with the inspection. Additionally, Bureau staff made attempts to contact the Institution by phone and email to gain access to the Institution for the unannounced compliance inspection. After trying to contact the Institution, Bureau staff waited at the Institution for one hour and was unable to complete the announced compliance inspection.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$5,000.00.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$501.00.

A reminder notice was sent to the Institution on or about the following dates: June 28, 2022, July 14, 2022, and July 26, 2022.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$5,000.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit the 2021 Annual Report pursuant to 5 CCR section 74110 and CEC section 94934.

If you wish to contest this citation, you may submit a written request to the Bureau or submit the enclosed Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing form within 30 days from the date of issuance of this citation.

Failure to submit a written request for an informal conference and/or administrative hearing within 30 days from the date of issuance of this citation will forfeit your ability to appeal the citation.

If a hearing is requested, you are not required to comply with this citation until a final order is entered against you.
