**NOTICE OF WITHDRAWAL OF
STATEMENT OF ISSUES**

17 TO ALL INTERESTED PARTIES:

18 PARTIES

19 1. On or about September 16, 2014, Joanne Wenzel, Chief of the Bureau for Private
20 Postsecondary Education, Department of Consumer Affairs (Bureau), filed Statement of Issues
21 No. 999515 solely in her official capacity.

22 2. On or about January 7, 2013, the Bureau received an Application for Verification of
23 Exempt Status from Cyber Insurance Group Corp, doing business as Cyber Insurance School
24 Corp. (Respondent.) The Bureau denied the Application on July 15, 2013. On January 27, 2014,
25 in Orange County Superior Court, Case No. 30-2014-00701565, captioned *Cyber Insurance*
26 *Group Corp, a California Corporation, doing business as Cyber Insurance School Corp. vs. The*
27 *Bureau for Private Postsecondary Education*, Respondent filed a Petition for Writ of Mandamus,
28 pursuant to Code of Civil Procedure section 1085, to challenge the denial by the Bureau of its

1 Application. On July 3, 2014, Respondent requested that the Bureau provide an administrative
2 hearing on the denial of the Application. On July 9, 2014, the Superior court issued an order
3 granting the Bureau's demurrer to the Petition for Writ of Mandamus, and dismissing
4 Respondent's Petition for Writ of Mandamus.

5 3. The basis for withdrawing the pending Statement of Issues in Case No. 999515 is
6 that on or about June 27, 2015, Respondent filed an Application for licensure with the Bureau.
7 On or about January 20, 2016, the Bureau granted Respondent's Application for licensure, and
8 therefore, on or about January 25, 2016, Respondent withdrew its request for hearing on the
9 denial of its Application for Verification of Exempt Status.

10 4. WHEREFORE, IN THE INTEREST OF JUSTICE, Statement of Issues No. 999515
11 is hereby withdrawn without prejudice.
