**A C C U S A T I O N**

18 Complainant alleges:

19 **PARTIES/LICENSING HISTORY**

- 20 1. Joanne Wenzel (Complainant) brings this Accusation solely in her official capacity as  
21 the Chief of the Bureau for Private Postsecondary Education "(Bureau)", Department of  
22 Consumer Affairs.  
23 2. On or about April 29, 2002, the former Bureau for Private Postsecondary and  
24 Vocational Education<sup>1</sup> ("BPPVE") issued an approval to operate to Triton Institute, Leslie  
25 Feltenberg, owner.

26 <sup>1</sup> The former Bureau for Private Postsecondary and Vocational Education sunsetted on  
27 July 1, 2007. On October 11, 2009, the Private Postsecondary Education Act of 2009 (AB 48)  
28 was signed into law. The Act, which became operative on January 1, 2010, established the  
Bureau for Private Postsecondary Education.

1           3.     Triton Institute's main campus' physical location is listed with the Bureau as 1107 N.  
2 Fair Oaks Ave., Sunnyvale, CA 94089.

3           4.     The BPPVE approved Triton Institute operate the following programs:

16           5.     In or about 2008, Leslie Feltenberg sold Triton Institute to Ling Li during the  
17 BPPVE's sunset period. Leslie Feltenberg passed away shortly thereafter.

18           6.     In or about 2012, Triton Institute moved to 830 Stewart Drive, Suite 151, Sunnyvale,  
19 CA 94085.

20           7.     On or about January 8, 2013, The Bureau received and application for change in  
21 educational objectives from Triton institute. The physical location of the main campus was listed  
22 on the application as 830 Stewart Drive, Suite 151, Sunnyvale, CA 94085. Ling Li was listed as  
23 the 75% owner. No information was listed for the ownership of the remaining 25%. The  
24 application requested to add massage therapy and healthcare information technology programs.  
25 The application is currently pending.

26           8.     On or about April 28, 2013, Triton Institute's approval to operate expired.

27     ///



1 (a) A change in educational objectives, including an addition of a new diploma or a degree  
2 educational program unrelated to the approved educational programs offered by the institution.

3 (b) A change in ownership.

4 (c) A change in control.

5 (d) A change in business organization form.

6 ...”

7 15. Section 94897 of the Education Code states:

8 "An institution shall not do any of the following:

9 ...

10 "(j) In any manner make an untrue or misleading change in, or untrue or misleading  
11 statement related to, a test score, grade or record of grades, attendance record, record indicating  
12 student completion, placement, employment, salaries, or financial information, including any of  
13 the following:

14 ...

15 "(3) Any other record or document required by this chapter or by the bureau.

16 "(k) Willfully falsify, destroy, or conceal any document of record while that document of  
17 record is required to be maintained by this chapter.

18 16. Section 94937 of the Education Code states:

19 "(a) As a consequence of an investigation, and upon a finding that an institution has  
20 committed a violation, the bureau may place an institution on probation or may suspend or revoke  
21 an institution's approval to operate for:

22 ...

23 "(2) A material violation or repeated violations of this chapter or regulations adopted  
24 pursuant to this chapter that have resulted in harm to students. For purposes of this paragraph,  
25 "material violation" includes, but is not limited to, misrepresentation, fraud in the inducement of  
26 a contract, and false or misleading claims or advertising, upon which a student reasonably relied  
27 in executing an enrollment agreement and that resulted in harm to the student.

28 ...”



1 SECOND CAUSE FOR DISCIPLINE

2 (Unauthorized Substantive Change to Approval to Operate)

3 22. Triton Institute, Ling Li, Owner, is subject to disciplinary action under Education  
4 Code sections 94893, and 94894, subdivision (b), in that the Triton Institute changed ownership  
5 without obtaining prior authorization from the Bureau. Ling Li purchased and began operating  
6 Triton Institute in 2008 without Bureau approval.

7 THIRD CAUSE FOR DISCIPLINE

8 (Unauthorized Substantive Change to Approval to Operate)

9 23. Triton Institute, Ling Li, Owner, is subject to disciplinary action under Education  
10 Code sections 94893, and 94894, subdivision (c), in that the Triton Institute had a change in  
11 control without obtaining prior approval from the Bureau. Ling Li purchased and began operating  
12 Triton Institute in 2008.

13 FOURTH CAUSE FOR DISCIPLINE

14 (Unauthorized Substantive Change to Approval to Operate)

15 24. Triton Institute, Ling Li, Owner, is subject to disciplinary action under Education  
16 Code sections 94893, and 94894, subdivision (d), in that the Triton Institute had a change in  
17 business organization form without obtaining prior approval from the Bureau. Triton Institute  
18 entered a partnership with School of Healing Touch to allow Triton Institute students to attend  
19 massage therapy classes at the School of Healing Touch. Triton Institute received 40% of the  
20 tuition collected.

21 FIFTH CAUSE FOR DISCIPLINE

22 (Untrue or Misleading Statements)

23 25. Triton Institute, Ling Li, Owner, is subject to disciplinary action under Education  
24 Code sections 94897, subdivision (j)(3), in conjunction with 94937, subdivision (a)(2), in that  
25 Triton Institute made untrue or misleading statements related to records indicating student  
26 completion. In or about April 2013, Triton Institute, in partnership with School of Healing  
27 Touch, sold transcripts and /or a certificate of completion to an undercover Division of  
28 Investigation operative. The transcripts and certificate of completion indicated the operative had

1 completed a 500 hour massage therapy program at Triton Institute when in fact she had not. This  
2 conduct resulted in harm to students.

3 SIXTH CAUSE FOR DISCIPLINE

4 (Falsifying Documents)

5 26. Triton Institute, Ling Li, Owner, is subject to disciplinary action under Education  
6 Code sections 94897, subdivision (k), in conjunction with 94937, subdivision (a)(2), in that the  
7 Triton Institute willfully falsified a document of record while that document of record is required  
8 to be maintained by this chapter. In or about April 2013, Triton Institute, in partnership with  
9 School of Healing Touch, sold transcripts and/or a certificate of completion to an undercover  
10 Division of Investigation operative. The transcripts and certificate of completion indicated the  
11 operative had completed a 500 hour massage therapy program at Triton Institute when in fact she  
12 had not. This conduct resulted in harm to students.

13 SEVENTH CAUSE FOR DISCIPLINE

14 (Failure to Collect Student Tuition Recovery Fund Fees)

15 27. Triton Institute, Ling Li, Owner, is subject to disciplinary action under Education  
16 Code sections 94937, subdivision (a)(2) in conjunction with California Code of Regulations, title  
17 5, section 76130, subdivision (a), in that Triton Institute failed to collect Student Tuition  
18 Recovery Fund Fees from the undercover Division of Investigation operative when she made her  
19 first payment. This conduct resulted in harm to students.

20 EIGHTH CAUSE FOR DISCIPLINE

21 (Location Change)

22 28. Triton Institute, Ling Li, Owner, is subject to disciplinary action under Education  
23 Code sections 94937, subdivision (a)(2) in conjunction with California Code of Regulations, title  
24 5, section 71660, in that Triton Institute changed its location (less than 10 miles) without first  
25 notifying the Bureau. This conduct resulted in harm to students.

2. Revoking or suspending School Code No. 194250 issued Triton Institute, Ling Li, Owner (Respondent);
3. Ordering Respondent to pay the Bureau the reasonable costs of the investigation and enforcement of this case pursuant to Education Code section 94937, subdivision (c) and Business and Professions Code section 125.3;
4. Ordering Respondent to provide appropriate restitution to its students and former students;
5. Taking such other and further action as deemed necessary and proper.
