LICENSING HISTORY

1. On or about February 27, 2018, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to Ding King Training Institute Inc., The (hereinafter referred to as the "Institution"). This Approval to Operate expired on or about February 27, 2023, has not been renewed.

4. On or about October 12, 2023, the Bureau issued Citation No. 2324056. On or about November 1, 2023, the Bureau received an appeal with a request for an informal conference. The informal conference was held on November 17, 2023. No new substantive facts were presented during the informal conference; therefore, the Bureau affirms Citation No. 2324056.

CAUSE FOR CITATION & ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

5. The Institution is in violation of the following Bureau laws and regulations:

Violation #1:

5 CCR section 74110 – Annual Report in conjunction with CEC section 94934 – Annual Report

Cause for Citation: A review of the Bureau's records confirm the Institution failed to submit all components of the 2021 Annual Report which was due to the Bureau by December 1, 2022. To date, the Bureau has not received financial statements as required.

Notices were sent to the Institution on or about the following dates: June 28, 2022, July 14, 2022, July 26, 2022, April 18, 2023, June 16, 2023, and July 5, 2023.

Administrative Fine: Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class A" violation. The Institution is issued a fine of \$2,501.00.

Order of Abatement: Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit all components of the 2021 Annual Report, pursuant to 5 CCR section 74110 and CEC section 94934.
