On July 17, 2020, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 1920310 (Citation) against California Coast University Employee Ownership Trust (ESOT), Owner of California Coast University (Institution). In attendance were California Coast University, Beth Danielson, Enforcement Chief and Christi Okuma, Director of Compliance and Operations.

Pursuant to Business and Professions Code, section 125.9; California Education Code, section 94936; and Title 5 of the California Code of Regulations, section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1920310.

It is the decision of the Enforcement Chief that on July 28, 2020 Citation No. 1920310 is <u>modified</u> and makes the following change(s):

(i) Job Placement Rates

(1) Any placement data required by sections 94910(b) and 94929.5(a) of the Code shall be reported for the number of students who began the program as defined in subdivision (d)(1) of this section for each reported calendar year.

(2) Placement is measured six months from the graduation date of each student. For programs that require passage of a licensing examination, placement shall be measured six months after the announcement of the examination results for the first examination available after a student completes an applicable educational program. Reporting of placement rates shall include for each educational program: the number of students who began the program, the number of graduates as defined in subdivision (b) section 94842 of the Code, the graduates available for employment, graduates employed

in the field and job placement rate(s).

(3) If the institution makes any claim related to preparing students for a job or regarding job placement,

(m) Documentation supporting all data reported shall be maintained electronically by the institution for at least five years from the last time the data was included in either an Annual Report or a Performance Fact Sheet, and shall be provided to the Bureau upon request; and the data for each program shall include at a minimum:

(1) the list of job classifications determined to be considered gainful employment for the educational program;

(2) student name(s), address, phone number, email address, program completed, program start date, scheduled completion date, and actual completion dates;

(3) graduate's place of employment and position, date employment began, date employment ended, if applicable, actual salary, hours per week, and the date employment was verified;

(4) for each employer from which employment or salary information was obtained, the employer name(s) address and general phone number, the contact person at the employer and the contact's phone number and email address, and all written communication with employer verifying student's employment or salary;

(5) for students who become self-employed, all documentation necessary to demonstrate self-employment;

(6) a description of all attempts to contact each student. or employer;

(7) any and all documentation used to provide data regarding license examinations and examination results;

(8) for each student determined to be unavailable for graduation or unavailable for employment, the identity of the student, the type of unavailability, the dates of unavailability, and the documentation of the unavailability; and

(9) the name, email address, phone number, and position or title of the institution's representative who was primarily responsible for obtaining the students' completion, placement, licensing, and salary and wage data, the date that the information was gathered, and copies of notes, letters or emails through which the information was requested and gathered."

Violation: 5 CCR, Section 74112(h): Bureau staff reviewed the 2016-2017 SPFS and found that the Associate of Science in Business Administration, Bachelor of Science in Criminal Justice, and Master of Science in Psychology programs incorrectly reported the Number of Students Who Began the Program and Number for On-Time Graduates, as the information did not match the 2017 supporting documentation.

WITHDRAWN

Violation: 5 CCR, Section 74112(i)(1)(2)(3)(4): Bureau staff reviewed the 2016-2017 SPFS and found that the Institution failed to report the Job Placement and Gainfully Employed.

WITHDRAWN

Violation: 5 **CCR, Section** 74112(m)(1)(2)(3)(4)(5)(6)(7)(8)(9): Bureau staff reviewed the 2016-2017 SPFS supporting documentation and found that the documentation failed to contain the requirements as outlined in subsections (m)(1)(5)(6)(7)(8)(9). Furthermore, Bureau staff found that subsection (m)(3) contained Graduate's Place of Employment and Position but failed to contain the additional requirements as outlined in subsection (m)(3). In addition, Bureau staff found that

Order of Abatement:

The Bureau orders the Institution to submit a policy, or procedure, of how future compliance with 5, CCR Section 74112 will be maintained.

Assessment of Fine

The fine for this violation is <u>\$5,000.00</u>

The administrative fine has been modified from <u>\$5,000.00</u> to <u>\$2,500.00</u>.

ORDER OF ABATEMENT

APPEAL OF CITATION

You *do not* have the right to request another Informal Conference to appeal this modified Citation. You *do*, however, have the right to appeal this affirmed or modified Citation through an Administrative Hearing. A hearing before an Administrative Law Judge will be scheduled and you will be notified of the hearing date. The hearing will be held pursuant to Chapter 5 (commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you do not wish to appeal this modified Citation you must withdraw your initial request for an Administrative Hearing, if one was made. Please complete and mail the enclosed <u>Withdrawal –</u> <u>Request for Administrative Hearing</u> within <u>**30 Days**</u> of the date of this decision.
