NOTICE OF WITHDRAWAL OF

20 **TO ALL INTERESTED PARTIES:**

21 1. On or about August 31, 2010, the Bureau for Private Postsecondary Education
22 (“Bureau”) received an Application for Renewal of Approval to Operate an Institution Non-
23 Accredited (application number 22868) from Respondent AB Truck Driving School; Mohan
24 Singh, 50% Owner; and Manjit Singh, 50% Owner (“Respondent”). Between July 30, 2011 and
25 March 21, 2014, the Bureau and Respondent exchanged correspondence regarding Respondent’s
26 application.

27 2. On or about July 23, 2015, the Bureau issued Respondent a Notice of Denial of
28 Application for Renewal of Approval to Operate. On or about August 18, 2015, the Bureau


1 received a request from Respondent for an administrative hearing regarding the denial of its
2 application.

3 3. On or about May 3, 2016, Respondent provided Complainant with a signed Notice of
4 Withdrawal of Request for Hearing. Respondent, through its counsel, had previously represented
5 to Complainant's counsel that Respondent intended to close its institution.

6 4. The Bureau hereby withdraws Statement of Issues No. 1000952. The basis for the
7 withdrawal of this pleading is that Respondent has withdrawn its request for hearing and
8 represented that it intends to close its institution.

9 5. WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.
10 1000952 is hereby withdrawn without prejudice.
