On September 14, 2016 an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No's: 1617012, 1617011, 1617013, 1617014, 1617015, 1617016, and 1617017 (Citation) against Fernando Sanchez, 25% owner, Bernardita Sanchez, 50% Owner, Esteban Ultra, 5% Owner, Anthony Sanchez, 5% Owner, Bernard Sanchez, 5% Owner, Giovanni Sanchez, 5% Owner, and Mark Sanchez, 5% Owner of Preferred College of Nursing Bakersfield. In attendance was Robert Bayles, Educational Administrator, and Fernando Sanchez, 25% owner.

Pursuant to Business and Professions Code, §125.9; California Education Code, §94936; and Title 5 of the California Code of Regulations, §75020 and §75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No's: 1617012, 1617011, 1617013, 1617014, 1617015, 1617016, and 1617017.

It is the decision of the Educational Administrator that on September 28, 2016 Citation No. 1617012, 1617011, 1617013, 1617014, 1617015, 1617016, and 1617017 are <u>modified</u> and make the following change(s):

### **VIOLATION CODE SECTIONS**

# The California Education Code (CEC) and the California Code of Regulations (CCR). Below you will find the section(s) you are charged with violating.

#### **MODIFIED**

#### 1. **Violation:**

5, CCR 74110 (a-d) - Annual Report

"(a) The annual report required by section 94934 of the Code shall include the information required by section 94934 for all educational programs offered in the prior calendar year. (b) In addition to the information required by section 94934 provided under penalty of perjury, the institution shall have annual financial statements prepared for the institution's prior fiscal year and signed under penalty of perjury, and shall submit a hard copy under separate cover of such statements in conjunction with its annual report. The form, content and mode of preparation of financial statements shall comply with section 74115 of this Division. The Bureau may request that the institution immediately make available for inspection to a representative of the Bureau, these financial statements at the offices of the institution. (c) An institution shall file its annual report by September 1st. The Bureau may extend the period for filing if the institution demonstrates evidence of substantial need but in no case longer than 60 days. The institution shall not change the date of its filing its annual report because of a change in the fiscal year without the Bureau's approval. (d) The annual report shall be electronically filed by submitting the information required by section 94934 of the Code via the Bureau's website, electronically attaching, as directed, the School Performance Fact Sheet and the school catalog. An institution without the capability to submit the information electronically shall inform the Bureau not less than 45 days prior to the date the information is required by subdivision (c), and receive direction on alternative means of submission."

# CEC 94934(a)(1-9) - Annual Report

- "(a) As part of the compliance program, an institution shall submit an annual report to the bureau, under penalty of perjury, signed by a responsible corporate officer, by July 1 of each year, or another date designated by the bureau, and it shall include the following information for educational programs offered in the reporting period:
- (1) The total number of students enrolled by level of degree or for a diploma.
- (2) The number of degrees, by level, and diplomas awarded.
- (3) The degree levels and diplomas offered.
- (4) The Student Performance Fact Sheet, as required pursuant to Section 94910.
- (5) The school catalog, as required pursuant to Section 94909.
- (6) The total charges for each educational program by period of attendance. (7) A statement indicating whether the institution is, or is not, current in remitting Student Tuition Recovery Fund assessments.
- (8) A statement indicating whether an accrediting agency has taken any final disciplinary action against the institution.
- (9) Additional information deemed by the bureau to be reasonably required to ascertain compliance with this chapter."

On 4/9/15, the Bureau mailed a letter to the institution stating that the 2014 Annual Report must be submitted beginning 7/1/15 and no later than 9/1/15. On 11/20/15, the Bureau mailed a second letter to the institution stating that the Bureau had not received the required 2014 Annual Report by the 9/1/15 deadline. To date, the institution has failed to file its 2014 Annual Report.

Reason for modification: The institution submitted 2014 Annual Report

The administrative fine for this violation has been modified from \$5,000.00 to \$501.00.

# APPEAL OF CITATION

You *do*, however, have the right to request another Informal Conference to appeal this modified Citation. You *do*, however, have the right to appeal this modified Citation through an Administrative Hearing, *only if* you initially requested one within 30 days from the issuance date of the original citation. A hearing before an Administrative Law Judge will be scheduled and you will be notified of the hearing date. The hearing will be held pursuant to Chapter 5 (commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code. If you did not initially request an Administrative Hearing within 30 days from when the original citation was issued, you can no longer request one.

If you do not wish to appeal this modified Citation you must withdraw your initial request for an Administrative Hearing, if one was made. Please complete and mail the enclosed <u>Withdrawal – Request for Administrative Hearing</u> within <u>30 Days</u> of the date of this decision.

#### EFFECTIVE DATE OF CITATION AND FINE ASSESSMENT

This modified Citation is effective on December 9, 2016. The order of abatement and payment are due by **January 8, 2016.**
