On June 9, 2016, an informal conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 1516093 (Citation) against Sima Dermishyan, Owner of Sacramento Ultrasound Institute. In attendance were Yvette Johnson, Enforcement Chief and Samuel Yarmagyan, Director.

Pursuant to Business and Professions Code, §148; California Education Code (CEC), §94944; and Title 5 of California Code of Regulations (5 CCR), §75020 and §75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1516093.

It is the decision of the Enforcement Chief that on June 10, 2016, Citation No. 1516093 is <u>modified</u> and makes the following change(s):

	recent Annual Report submitted to the Bureau. As of May 4, 2016, SUI's web site still lacked the most recent Annual Report.
	<u>Order of Abatement:</u> The Bureau orders that SUI provide its most recent Annual Report to its web site.
	<u>Assessment of Fine</u> The fine for this violation is <u>\$2,500.00</u>
	Reason for modification: The institution's website is now in compliance.
	The administrative fine for this violation has been modified from \$2,500 to <u>\$1,050.00</u>

As of May 4, 2016, SUI's website continued to lack a link to the Bureau's web site.
	<u>Order of Abatement:</u> The Bureau orders that SUI update its web site to include a link to the Bureau's web site.

	Reason for modification: The institution's website is now in compliance.
	The administrative fine for this violation has been modified from \$2,500 to <u>\$1,050.00</u>

	Performance Fact Sheets to its web site. However, upon reviewing SUI's web site again on April 25, Page 2 of 4

Citation No. 1516093 –MODIFIED Sima Dermishya, owner of Sacramento Ultrasound Institute 2016, Bureau Staff found that SUI has since updated its web site to include its School Performance Fact Sheets.

Order of Abatement:

The Bureau orders that SUI maintain its web site to continue compliance with CEC 94913 (a)(2).

APPEAL OF CITATION

You *do not* have the right to request another Informal Conference to appeal this modified Citation. You *do*, however, have the right to appeal this modified Citation through an Administrative Hearing, *only if* you initially requested one within 30 days from the issuance date of the original citation. A hearing before an Administrative Law Judge will be scheduled and you will be notified of the hearing date. The hearing will be held pursuant to Chapter 5 (commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code. If you did not initially request an Administrative Hearing within 30 days from when the original citation was issued, you can no longer request one.

EFFECTIVE DATE OF CITATION AND FINE ASSESSMENT

This modified Citation is effective on June 10, 2016. The payment is due by **July 9, 2016**.

Failure to pay the administrative fine within the time allowed is grounds for denial of an application for an approval to operate or discipline. The Bureau will promptly take all appropriate action to enforce the Modified Citation and recover the civil penalties prescribed therein or found to be due after a hearing.
