WITHDRAWAL OF ACCREDITATION - FINAL ACTION

Pursuant to Section X(C)(4), Rules of Process and Procedure, Standards of Accreditation, the Commission, no later than 60 days after a final decision to deny or withdraw accreditation, will make available to the U.S. Department of Education, the appropriate state licensing agency, and other accrediting agencies the reasons for the Commission's decision. A final decision to deny or withdraw accreditation is one reached after a school has exhausted the appeals process provided for under Section VII, Rules of Process and Procedure, Standards of Accreditation.
