

§94900. Required Student Records	(b) An institution shall maintain, for each student granted a degree or certificate by that institution, permanent records of all of the following: (1) The degree or certificate granted and the date on which that degree or certificate was granted. (2) The courses and units on which the certificate or degree was based. (3) The grades earned by the student in each of those courses. The Institution failed to provide a student transcript in the files.

Code of Regulations	Subsection and Description
§71770 - Admissions Standards and Transferred Credits Policy.	(a)The institution shall establish specific written standards for student admissions for each educational program. These standards shall be related to the particular educational program. An institution shall not admit any student who is obviously unqualified or who does not appear to have a reasonable prospect of completing the program. In addition to any specific standards for an educational program, the admissions standards must specify as applicable that: (1)Each student admitted to an undergraduate degree program, or a diploma program, shall possess a high school diploma or its equivalent, or otherwise successfully take and pass the relevant examination as required by section 94904 of the Code. The Institution failed to maintain a High School Diploma, GED or its equivalent, or otherwise successfully take and pass the relevant examination as required by section 94904 of the Code in the student files.
§71920 - Student Records.	(b)In addition to the requirements of section 94900, the file shall contain all of the following pertinent student records: (10)A document specifying the amount of a refund, including the


