- 94910 (a)-(g): School did not have a School Performance Fact Sheet. This document was new information to institution, and school stated they did not know what it is.
- 76140(a)(1)-(13): School did not have student data information in correct template.
- 71735(b): School did not have available to review: the health + safety permit, nor the building safety permit or business tax license.
- ~~71720 (b)(1): CAO file and both instructor files only contained resumes. There were no other documents, such as educational (eg, copy of degree) or experiential qualifications, no CPE certificates or EMT certificates in files.~~
- 71730 (b): School did not have personnel manual, policies + procedures (administrative), nor performance evaluation criteria established for faculty/administrator/instructors.
