§71930(d) - Administration	<p>The institution shall maintain a second set of all academic and financial records required by the Act and this chapter at a different location unless the original records, including records stored pursuant to subdivision (b) of this section, are maintained in a manner secure from damage or loss. An acceptable manner of storage under this subdivision would include fire resistant cabinets.</p> <p>Student records/files were stored in file cabinets that were not fire resistant. (School does not have a second set of all academic and financial records stored at a different location; thus, the file cabinets must be secure from damage or loss.)</p>
