Most Student files did not contain High school diploma, transcripts, ~~(W)~~ or GED, verification. Some files contain 'Certification Letter' which student certifies under penalty of perjury the high school they attended, location of high school, years of attendance, and high school graduation date; however, the files did not contain proof/copy of diploma and the "Certification Letter" is NOT an acceptable verification document per statute.

* NOTE: Evidence of files show school attempted to receive copies of transcripts or high school diplomas from the students' previous high schools; however, institution indicates some high schools never responded.
