§94911 - Minimum Requirements for Enrollment Agreement.	(c) In underlined capital letters on the same page of the enrollment agreement in which the student's signature is required, the total charges for the current period of attendance, the estimated total charges for the entire educational program, and the total charges the student is obligated to pay upon enrollment. <b>The institutions Enrollment Agreement failed to include the required language.</b>
