FACT: There were no copies of high school completion or equivalent and no transcripts in student files that verified high school completion. School administrator states that institution does not ask for students' proof of high school diploma, GED, or ATB prior to admission. School generally goes by work-force experience / industry experience a student had.

Correction: Going forward, institution must require of all students who wish to be admitted, one of the following: H.S. Diploma, GED, ATB, or transcript to verify student completed high school. School submitted letter informing they will do this requirement. In addition, school will contact current students on files reviewed to ask for proof of high school completion and
