In addition to any specific standards for an educational program, the admissions standards must specify as applicable that:</p> <p>(1)Each student admitted to an undergraduate degree program, or a diploma program, shall possess a high school diploma or its equivalent, or otherwise successfully take and pass the relevant examination as required by section 94904 of the Code.</p> <p>Student files for the Nursing Assistant program did not contain High School Diplomas or equivalent.</p>
§71920 - Student Records.	<p>(b)In addition to the requirements of section 94900, the file shall contain all of the following pertinent student records:</p> <p>(1)Written records and transcripts of any formal education or training, testing, or experience that are relevant to the student's qualifications for admission to the institution or the institution's award of credit or acceptance of transfer credits including the following: (A) Verification of high school completion or equivalency or other documentation establishing the student's ability to do college level work, such as successful completion of an ability-to-benefit test.</p> <p>Student files for the Nursing Assistant program did not contain High School Diplomas or equivalent.</p>



