


§71920 - Student Records.	(b) In addition to the requirements of section 94900, the file shall contain all of the following pertinent student records: (5) In addition to the requirements of section 94900(b) of the Code, a transcript showing all of the following: (A) The courses or other educational programs that were completed, or were attempted but not completed, and the dates of completion or withdrawal; (E) The name, address, website address, and telephone number of the institution. The institution's transcript does not include dates of completion or withdrawal nor the address, website address, and telephone number of the institution.
