(b)(1)(A): Catalog states in their Admissions Requirements a "High School Diploma or GED"; however, all student files did not contain H.S. diploma, transcript, or proof of high school graduation nor a GED on file. Owner Ms. Lindell Naito-Zieg attested she has never asked for H.S. diploma or verification of graduation, ATB or GED from students prior to admission
§71770 - Admissions Standards and Transferred Credits Policy.	(a)(1): This statute accompanies §71920 and §94904, since institution has not been referring or informing students they have the option to take and pass an ATB test prior to admission.
§74112 - Uniform Data - Performance Fact Sheet.	School provided SPFS, but it was not in the correct template/format, as per §74112.
