23 Postsecondary Education, Department of Consumer Affairs (hereinafter "Bureau"), filed  
24 Statement of Issues No. 999667 solely in her official capacity.
- 25 2. On or about January 30, 2012, the Bureau for Private Postsecondary Education  
26 (hereinafter "Bureau") received an application for a Renewal of Approval to Operate a Non-  
27 Accredited Institution (Application #24351) from Rosston School of Hair Design; Bhaskara  
28 Reddy V. Munagala, 50% owner and Padmaja Reddy Munagala, 50% owner (Respondent). On


1 or about January 24, 2012, Bhaskara Reddy V. Munagala and Padmaja Reddy Munagala certified  
2 under penalty of perjury to the truthfulness of all statements, answers, and representations in the  
3 application. The Bureau denied the application on March 19, 2014.

4 3. The basis for withdrawing the pending Statement of Issues No. 999667 is that all of  
5 the deficiencies in the application for Renewal of Approval to Operate a Non-Accredited  
6 Institution (Application #24351) were cured.

7 4. WHEREFORE, IN THE INTEREST OF JUSTICE, Statement of Issues No. 999667  
8 is hereby withdrawn without prejudice.
