12	14. Respondent's application is subject to denial based upon their financial	
13	documentation which reflects that there are insufficient assets or resources as required by Title 5,	
14	California Code of Regulation Section 71745 (a)(1-5) in that their statement of cash flow shows a	
15	negative \$82,466. Additionally, the financial statements submitted to the Bureau, for the year	
16	ending October 31, 2013, the company incurred a net loss of \$38,028. The same financial	
17	statement indicates that the company had not filed its 2012 federal or state tax returns.	
18	A financial Statement for year ending December 31, 2013, was also submitted to the	
19	Bureau which in their statement of cash flow shows a negative \$83,543. Additionally the	
20	financial statements show a net income loss of \$44,937.
