19 **NOTICE OF WITHDRAWAL OF**
STATEMENT OF ISSUES

20 **TO ALL INTERESTED PARTIES:**

21 1. On or about January 3, 2014, the Bureau for Private Postsecondary Education
22 (Bureau) received an Application for Renewal of Approval to Operate an Institution Non-
23 Accredited (application number 26952) from AC College Inc., d.b.a. American Century College;
24 Ali Mirzaei, Owner (Respondent). On or about January 9, 2014, the Bureau issued a deficiency
25 letter to Respondent. On or about January 27, 2014, the Bureau received a response to its January
26 9, 2014 letter. On or about August 25, 2014, the Bureau received an updated Application for
27 Renewal of Approval to Operate. On or about October 2, 2014, the Bureau spoke with
28 Respondent regarding deficiencies in its application. On or about October 3 and 6 and November
7, the Bureau received further information from Respondent. On or about December 3, 2014, the

1 Bureau issued Respondent an additional deficiency letter. On or about January 6, 2015, the
2 Bureau received a response to its December 3, 2014 deficiency letter. On or about March 30,
3 2015, the Bureau issued Respondent a Notice of Denial of Application for Renewal of Approval
4 to Operate. On or about May 28, 2015, Respondent submitted to the Bureau a request for appeal
5 in an administrative hearing.

6 2. On or about August 31, 2015, Joanne Wenzel, Chief of the Bureau for Private
7 Postsecondary Education, Department of Consumer Affairs, filed Statement of Issues No.
8 1000735 solely in her official capacity.

9 3. The basis for withdrawing the pending Statement of Issues No. 1000735 is that, on
10 November 3, 2015, the Bureau's counsel received, via email, Respondent's Notice of Withdrawal
11 of Request for Hearing.

12 4. WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.
13 1000735 is hereby withdrawn without prejudice.
