**NOTICE OF WITHDRAWAL OF  
STATEMENT OF ISSUES**

18 TO ALL INTERESTED PARTIES:

19 1. On or about March 19, 2012, the Bureau for Private Postsecondary Education  
20 ("Bureau") received an Application for Renewal of Approval to Operate an Institution Non-  
21 Accredited (application number 24580) from Revere Academy of Jewelry Arts; Alan Revere,  
22 Owner ("Respondent"). On or about April 24, 2012, the Bureau issued Respondent a deficiency  
23 letter. The Bureau issued Respondent a subsequent deficiency letter on or about September 30,  
24 2013. Between January 30, 2014 and December 8, 2014, Respondent and the Bureau  
25 communicated and corresponded regarding Respondent's application.

26 2. On or about July 23, 2015, the Bureau issued Respondent a Notice of Denial of  
27 Application for Renewal of Approval to Operate. On or about August 14, 2015, Respondent  
28 requested an administrative hearing regarding the Bureau's denial of its application.

1           3.     On or about November 16, 2015, Joanne Wenzel, Chief of the Bureau for Private  
2 Postsecondary Education, Department of Consumer Affairs, filed Statement of Issues No.  
3 1000953 solely in her official capacity. After the filing of that Statement of Issues, Respondent  
4 provided additional documents intended to resolve issues of non-compliance in Respondent's  
5 application.

6           4.     The Bureau hereby withdraws Statement of Issues No. 1000953. The basis for the  
7 withdrawal of this pleading is that Respondent has now provided the documents and other  
8 information necessary for its renewal of licensure.

9           5.     WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.  
10 1000953 is hereby withdrawn without prejudice.
