STUDENT'S RIGHT TO CANCEL

Students will be permitted to withdraw from their enrollment in the California University of Science and Medicine (CUSM) School of Medicine (CalMed) MD program, without any penalty or obligation, during the first seven (7) days of the first semester. In this case, the late payment fee will also be waived/refunded. After this initial seven (7) days, tuition refunds may be applicable based on the Tuition Refund Policy in the CUSM Catalog.

To withdraw from the CalMed MD program, the student will be required to mail or deliver a signed and dated copy of a notice of their intent to withdraw to:

NOTE: All withdrawals must be in writing (an email notification is not acceptable). Students will be informed that they do not have the right to withdraw by telephoning the university or by not attending class.

Return of Equipment

Upon withdrawal, any payments made and/or any negotiable instruments signed by students shall be returned within 45 days following the receipt of the notice to withdraw from the program.

Students who withdraw and may have received any equipment, will be required to return the equipment within 30 days of the date they signed the notice of withdrawal. Failure to return the equipment within this 30-day period, will serve as permission for CalMed to withhold from any refunded amount an amount equal to the cost of the equipment. The total amount charged for each item of equipment shall not exceed the equipment's replacement value including the University's overhead.
