In order to obtain the proper form for cancellation of enrollment before term of study begins, the student must write the Registrar's Office at California Christian College, 5364 East Belmont Avenue, Fresno, CA 93727 and specifically request the Cancellation of Enrollment Agreement Form.

Cancellation is effective on the date written notice of cancellation is sent. The institution shall make the refund pursuant to section 71750 of the Regulations.

Distance Education: If the institution sent the first lesson and materials before an effective cancellation notice was received, the institution shall make a refund within 45 days after the student's return of the materials. (5 CCR §71716(b)(d)).

No student will be re-enrolled for another semester without complete payment of the student's indebtedness to CCC, except under special circumstances arranged in conjunction with the President and financial office.
