- 3. The written notice of cancellation, if sent by mail, is effective when deposited in the mail (postmarked) properly addressed with proper postage.
- 4. The written notice of cancellation need not take any particular form and, however expressed, it is effective if it shows that the student no longer wishes to be bound by the Enrollment Agreement.
- 5. If the Enrollment Agreement is cancelled the school will refund the student any money paid towards the tuition within 45 days after the notice of cancellation is received, less a registration not to exceed \$100.00, and deductions for equipment not returned in good condition.
- 6. In the event that fees are collected in advance of the start date of a program and BAC cancels the class, 100% of the tuition and fees collected will be refunded within five (5) business days of the notice of the class cancellation.
