session the right of the s	ve the right to cancel your program of instruction, without any penalty or obligations, through attendance at the first class or the seventh calendar day after enrollment, whichever is later. After the end of the cancellation period, you also have not to stop school at any time; and you have the right to receive a pro rata refund if you have completed 60 percent or less scheduled days (or hours) in the current payment period in your program through the last day of attendance. Cancellation agreement can occur up to:
1.	Cancellation may occur when the student provides a written notice of cancellation at the following address: Rosemead Beauty School, Attn: Kenneth Yong, 8531 East Valley Boulevard, Rosemead, CA 91770. This can be done by mail or by hand delivery. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
