STUDENT'S RIGHT TO CANCEL

California Truck Driving Academy's refund policy has been established so that the student or any eligible veteran who cancels the enrollment agreement can obtain a refund of charges paid through attendance at the first-class session, or the seventh day after enrollment, whichever is later (see page 1).
