**NOTICE OF WITHDRAWAL OF**  
**STATEMENT OF ISSUES**

18 **TO ALL INTERESTED PARTIES:**

19 1. On April 30, 2015, the Bureau for Private Postsecondary Education (Bureau) received  
20 an Application for Approval to Operate for an Institution Non Accredited (Application Number  
21 28287) from Goldenville University, School of Management and Leadership (Respondent). On  
22 March 15, 2016, the Bureau sent Respondent a letter requesting additional information and  
23 documents, in order for the Application to be deemed complete. On August 2, 2016, the Bureau  
24 denied the application. On September 24, 2016, Respondent sent a letter to the Bureau requesting  
25 an administrative hearing to appeal the Bureau's denial of its application.

26 2. On or about February 2, 2017, Joanne Wenzel, Chief of the Bureau for Private  
27 Postsecondary Education, Department of Consumer Affairs, filed Statement of Issues No.  
28 1002140 solely in her official capacity. After the filing of that Statement of Issues, Respondent

1 provided additional documents intended to resolve issues of non-compliance in Respondent's  
2 Application.

3 3. The Bureau hereby withdraws Statement of Issues No. 1002140. The basis for the  
4 withdrawal of this pleading is that Respondent sent the Bureau written notice withdrawing its  
5 request for an administrative hearing to appeal the denial of its application, a copy of which is  
6 attached hereto as **Exhibit A**.

7 4. WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues No.  
8 1002140 is hereby withdrawn without prejudice.
