23 1. On or about December 17, 2018, Dr. Michael Marion, Jr., Chief of the Bureau for
24 Private Postsecondary Education, Department of Consumer Affairs (hereinafter "Bureau"), solely

26 2. On or about March 21, 2017, the Bureau received an application for an Approval to
