21 TO ALL INTERESTED PARTIES:

22 1. On or about March 28, 2019, Dr. Michael Marion, Jr., in his official capacity as the
23 Chief of the Bureau for Private Postsecondary Education, Department of Consumer Affairs
24 (Bureau), filed Statement of Issues number 1003472.

25 2. On or about August 2, 2013, the Bureau for Private Postsecondary Education received
26 an Application for Renewal for Approval to Operate for an Institution Non Accredited from
27 College of Southern California with Aaron Rhee as owner (Respondent). On or about July 22,
28 2013, Aaron Rhee certified under penalty of perjury to the truthfulness of all statements, answers,

1 and representations in the application. After several notices of deficiencies and some further
2 information from Respondent, on or about April 23, 2018, the Bureau denied the application. On
3 or about May 7, 2018, the Bureau received a letter from Respondent requesting an administrative
4 hearing.

5 3. The basis for withdrawing the pending Statement of Issues number 1003472 is that
6 Respondent has now provided the documents and other information necessary to cure all
7 deficiencies and receive a Renewal for Approval to Operate for an Institution Non Accredited.

8 WHEREFORE, IN THE INTERESTS OF JUSTICE, Statement of Issues number 1003472
9 is hereby withdrawn without prejudice.
