On March 7, 2019, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 1819101 (Citation) against Kyoko Amemiya, Owner of Atlas Studio. In attendance were Leeza Rifredi, Deputy Bureau Chief; Kyoko Amemiya, Owner; and Mathew Eanet, Attorney.

Pursuant to Business and Professions Code, section148; California Education Code (CEC), section 94944; and Title 5 of California Code of Regulations (5, CCR), section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1819101.

It is the decision of the Deputy Bureau Chief that on March 7, 2019, Citation No. 1819101 is <u>modified</u> and makes the following change(s):

CEC Section 94869. To Operate

"To operate" means to establish, keep, or maintain any facility or location in this state where, or from which, or through which, postsecondary educational programs are provided."

On April 10, 2019, during the investigation, Bureau staff discovered that the Institution is in operation through its website <u>www.english.atlasstudiousa.com</u>. Bureau staff searched the Institution's website and discovered the Institution is advertising a 100-hour professional nail course for \$4,000 and a 36-hour eyelash extension professional course for \$2,400.

Bureau staff received documentation from a former student which included a nail school price list highlighting a program cost of \$3,300. The student provided a bank statement and a copy of a receipt which shows a payment of \$3,300 was made to the Institution.

Based on the Bureau's investigation, the Institution is operating as a private postsecondary educational institution at 2228 Newport Blvd Suite C, Costa Mesa, California 92627, and is not exempt from the provisions of the California Private Postsecondary Act. The Institution advertises a program costing \$4,000, falls under the definition of a private postsecondary educational institution under CEC section 94858 and continues to operate without Bureau approval.

Order of Abatement:

The Bureau orders that the Institution cease to operate as a private postsecondary educational institution, unless the Institution qualifies for an exemption under CEC section 94874. The Institution must discontinue recruiting or enrolling students and cease all instructional services and advertising in any form or type of media, including the <u>www.atlasstudiousa.com</u>, <u>www.english.atlasstudio.com</u>, and <u>www.amelbo.jp/atlasstudiousa</u> and any other websites not identified here that are associated with the Institution, until such time as an approval to operate is obtained from the Bureau. The Institution must disconnect all telephone service numbers including but not limited to (714) 429-1048 that are associated with the Institution until such time as an approval to operate is obtained from the Bureau. To comply with the Order of Abatement the Institution must submit a school closure plan to the Bureau pursuant to California Education Code section 94926. The Institution must provide a roster of each student currently enrolled at the Institution. The roster must include the names of the students, their contact information (including phone number, email address, and physical address), the programs in which they are enrolled, the amount paid for the programs.

<u>Reason for modification</u>: New substantive facts were presented at the conference.

The administrative fine for this violation has been modified from \$75,000.00 to \$10,000.00.

APPEAL OF CITATION

You *do not* have the right to request another Informal Conference to appeal this modified Citation. You *do*, however, have the right to appeal this modified Citation through an Administrative Hearing, *only if* you initially requested one within 30 days from the issuance date of the original citation. A hearing before an Administrative Law Judge will be scheduled and you will be notified of the hearing date. The hearing will be held pursuant to Chapter 5 (commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code. If you did not initially request an Administrative Hearing within 30 days from when the original citation was issued, you can no longer request one.

If you do not wish to appeal this modified Citation you must withdraw your initial request for an Administrative Hearing, if one was made. Please complete and mail the enclosed <u>Withdrawal –</u> <u>Request for Administrative Hearing</u> within **<u>30 Days</u>** of the date of this decision.

EFFECTIVE DATE OF CITATION AND FINE ASSESSMENT

This modified Citation is effective on March 26, 2019. The payment is due by April 25, 2019.

Failure to abate the violation or to pay the administrative fine within the time allowed is grounds for denial of an application for an approval to operate or discipline. The Bureau will promptly take all appropriate action to enforce the Modified Citation and recover the civil penalties prescribed therein or found to be due after a hearing.
