On April 18, 2019, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 1819138 (Citation) against Sterling Schools, L.L.C., Owner of Lu Ross Academy. In attendance were Beth Scott, Enforcement Chief; Ken Boyle, Owner, Sherri Silva, Placement Coordinator; and Alma Moreno, School Director.

Pursuant to Business and Professions Code, section 125.9; California Education Code, section 94936; and Title 5 of the California Code of Regulations, section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1819138.

  salary and wage data, the date that the information was gathered, and copies of notes,
  letters or emails through which the information was requested and gathered.

## **Order of Abatement:**

The Bureau orders the Institution to provide the Bureau with a policy and procedure of how the Institution will maintain supporting documentation, per 5, CCR section 74112 (m).

Reason for modification: New substantive facts were presented at the conference.
